DISHONoured CHEQUES

If your bank refuses to honour a cheque that you have given as payment for a booking fee then an administration fee of £10 will be charged. This will be charged every time a cheque is returned and no exceptions are made.

YOUR COMMITMENT TO AN EVENT

Details about the event will be sent out to all traders two weeks before the event. All traders must read these guidelines, be set up by the required time and not break down a stall until the specified time.

Pitch fees are based on approx. 3m x 3m areas. The event is held *inside* the Cattle Sheds but as it is such a large space we ask people to trade from your own individual gazebo rather than just tables. You must provide your own tables and gazebo.

If you trade from a van then you are able to bring this inside the Cattle Sheds. Please let us know if you use gas. If your pitch is larger than 3m x 3m then please contact Suffolk Market Events before booking.

All rubbish **MUST** be removed by you.

ELECTRICITY

You must specify the total wattage of electricity you require at the event on the booking form.

You must supply your own extension cables at all events where you require power. All electrical equipment must be in possession of a current PAT certificate.

INSURANCE

Suffolk Market Events is not responsible for any loss, theft or damage to your property or stock at this event. All stallholders must carry adequate insurance and provide a copy of their PL Insurance to Suffolk Market Events at the time of submitting the booking form. Food producers must also provide their Certificate of Premises inspection from the local authority at the time of booking.

CANCELLATION POLICY

Cancellation more than 4 weeks before the event: a full refund will be paid minus £15 admin fee, *on the condition that Suffolk Market Events is able to find an appropriate replacement producer* to take the pitch. If no suitable replacement producer is available, then no refund will be given.

Cancellation less than 4 weeks before the event: no refund will be given.

Events are subject to cancellation or rescheduling at the discretion of Suffolk Market Events and the Suffolk Agricultural Association with whom we are collaborating for this event.

If the event is cancelled in its entirety, due to circumstances beyond our control, including Covid 19, then we shall have no liability for losses or costs which you may incur due to such cancellation but we shall refund 50% of your booking payment. We may change the terms upon which we make events available from time to time without notice to you and any subsequent booking requests you may make will be subject to those changes.
